INSTRUCTION SHEET FOR PERMITS

1. Pick up application forms and complete same.
2. For All work in right-of-way, paving, concrete curb, gutters and driveway aprons, utility work, or excavations greater than 18", submit form to the City Clerk's Office, along with a plan showing proposed curb elevations, nearest inlet and any other utilities within fifty (50) feet and appropriate fee. Plan must also show a detail of the proposed work.
3. For all sidewalk work only submit form to the City of Northfield Zoning Office, along with a plan showing proposed curb elevations, nearest inlet and any other utilities within fifty (50) feet and appropriate fee. Plan must also show a detail of the proposed curb, gutter and driveway.

5. All applicants must call the one-call mark out system at 1-800-272-1000 prior to any work being carried out.
6. 48 hours notice must be given to prior to any work being carried out.
7. The applicant agrees to comply with the regulations contained in the ordinance governing installation or alteration of curbs/ driveways and sidewalks in the City of Northfield, as well as all laws, ordinances and resolutions relating to said work and the acceptance of the permit shall be deemed an agreement to abide by all of its terms and conditions.
8. This permit grants permission to perform curb / driveway and sidewalk installation within the road right-of-way. All work within the property boundaries must comply with the zoning regulations and requires approval from the construction official.
9. Any damage to the existing road will have to be repaired as per Chapter 330 of the City of Northfield Code.
