Exceptions

- Newly acquired animals must be licensed within ten (10) days of acquisition.
- Animals must be licensed within ten (10) days of reaching licensing age.
- Animals currently licensed in another state must be re-licensed in the City within ninety (90) days.

All licenses expire on December 31<sup>st</sup> of each year. **In calendar year 2020 only, renewal licenses can be purchased without penalty between January 1<sup>st</sup> and May 31<sup>st</sup>. A Late Fee of \$5.00 will be charged on all unlicensed pets after May 31, 2020.** No dogs or cats are permitted to run at large. Owners will be subject to a fine. Northfield has a Running at Large Ordinance and a "Pooper-Scooper" Ordinance.
