### **MAYOR'S REPORT**

#### **CITY ENGINEER'S REPORT**

Engineer Mauro announced one of their roles was to pursue funding opportunities and municipal projects. They were working on two grant opportunities, one new and one existing. Thew new one was the Local Recreation Improvement Grant (LRIG), it was sponsored by the DCA, for recreational purposes. They will be meeting with the City to see what the City's needs are, it was due February 27<sup>th</sup>. Solicitor Facenda read the following into the record:

### "CITY OF NORTHFIELD, NJ RESOLUTION NO. 42-2024

# RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF NORTHFIELD AUTHORIZING THE EXECUTION OF AN AMENDED SETTLMENT AGREEMENT BETWEEN THE CITY AND FAIR SHARE HOUSING CENTER

WHEREAS, pursuant to In re N.J.A.C. 5:96 and 5:97, 221 N.J. 1 (2015)(Mount Laurel IV), on July 2, 2015, the City of Northfield (hereinafter the "City") filed a Declaratory Judgment Complaint in Superior Court, Law Division seeking, among other things, a judicial declaration that its Housing Element and Fair Share Plan (hereinafter "Fair Share Plan"), to be amended as necessary, satisfies its "fair share" of the regional need for low- and moderate-income housing pursuant to the "Mount Laurel doctrine"; and

WHEREAS, the City simultaneously sought, and ultimately secured, a protective order providing the City of Northfield immunity from all exclusionary zoning lawsuits, including builder's remedy lawsuits, while it pursues approval of its Fair Share Plan, which is still in full force and effect; and

WHEREAS, the Court also appointed Steven P. Perskie, J.S.C. (Ret.) as the Special Court Master (hereinafter the "Court Master"), as is customary in <u>Mount Laurel</u> matters adjudicated in the courts; and

WHEREAS, under the supervision of the Court Master, the City and Fair Share Housing Center ("FSHC") entered into a Settlement Agreement on April 24, 2018 (hereinafter "2018 Settlement Agreement"), which was thereafter approved by a Court Order entered on June 19, 2018, after a properly noticed Fairness Hearing that was held on June 1, 2018; and

**WHEREAS**, the Court issued a Conditional Judgment of Compliance and Repose ("JOR") to the City on August 31, 2018; and

WHEREAS, since the entry of the JOR, the Diocese of Camden and the County have begun discussions on creating a 100% affordable senior rental project on County-owned property located in the City, which will benefit the City's current and future residents, as well as very-low, low- and moderate-income households in the region; and

WHEREAS, FSHC and the City have agreed that the Diocese Project will be a beneficial addition to the City's Housing Element and Fair Share Plan; and

**WHEREAS**, the City and FSHC have agreed that an Amendment to the FSHC Settlement Agreement needs to be entered into to address proposed changes to the 2018 Settlement Agreement; and

WHEREAS, in order to implement the proposed changes, in addition to amending the City's Affordable Housing Plan, it is also necessary to amend the 2018 Settlement Agreement accordingly, and this Amendment to the FSHC Settlement Agreement serves that purpose.

**NOW, THEREFORE, BE IT RESOLVED** on this 16th day of January, 2024, by the City Council of the City of Northfield, County of Atlantic, State of New Jersey, as follows:

- 1. The City Council hereby authorizes and directs the Mayor of the City of Northfield to execute the Amendment to the FSHC Settlement Agreement.
- 2. The City Council hereby directs the City's Affordable Housing Counsel to (a) file the Amendment to the FSHC Settlement Agreement with the Court for review and approval at a duly noticed Fairness Hearing, and (b) take all actions reasonable and necessary to secure an Order approving the Amendment to the FSHC Settlement Agreement.
- I, Shannon Campbell, Deputy Municipal Clerk of the City of Northfield, do hereby certify that the foregoing Resolution was duly adopted at a Regular Meeting of the Common Council of the City of Northfield, held this 16th day of January, 2024.
