THIS RIGHT-OF-WAY USE AGREEMENT (the "Agreement") is dated _____, 2025 (the "Effective Date"), and entered into by and between the City of Northfield (the "Municipality"), a New Jersey municipal corporation, with offices at 1600 Shore Road, Northfield, New Jersey 08225, and Netspeed LLC d/b/a GoNetspeed ("GoNetspeed"), a Delaware limited liability company, with offices at 396 Griffin Road, Suite 110, Bangor, ME 04401.

WHEREAS, GoNetspeed has been approved by the New Jersey Board of Public Utilities ("BPU") to provide local exchange and interexchange telecommunications services throughout the State of New Jersey, and pursuant to such authority granted by the BPU, GoNetspeed may locate, place, attach, install, operate and maintain facilities within municipal rights-of-way for purposes of providing telecommunications services; and

WHEREAS, GoNetspeed has proposed to place its telecommunications facilities aerially on existing utility poles or in underground conduit in the public rights-of-way within the Municipality for the purpose of owning, constructing, installing, operating, repairing and maintaining a telecommunications system; and

WHEREAS, it is in the best interest of the Municipality and its citizens for the Municipality to grant consent to GoNetspeed to occupy said public rights-of-way within the Municipality for this purpose; and

WHEREAS, the consent granted herein is for the non-exclusive use of the public rights-of-way within the Municipality for the purpose of owning, constructing, installing, operating, and maintaining a telecommunications system;

WHEREAS, the Municipality requires indemnification and insurance from GoNetspeed in connection with this consent;

NOW THEREFORE, in consideration of the mutual covenants and obligations hereinafter set forth, the Municipality and GoNetspeed hereby agree to and with each other as follows:

Section 1. Grant of Consent; Conditions. Permission and authority are hereby granted to GoNetspeed and its successors and assigns, to use poles erected by parties that have the lawful right to maintain poles within the public right-of-way in the Municipality, subject to the following:

- i. GoNetspeed, and its successors and assigns, shall adhere to all applicable Federal, State, and Local laws regarding safety requirements related to the use of the public right-of-way, and shall obtain any applicable permits that may be required by the Municipality/
- ii. Such permission is hereby given upon the condition and provision that GoNetspeed, and its successors and assigns, shall indemnify, defend and hold harmless the Municipality, its officers, agents, and servants, from any claim of liability or loss or bodily injury or property damage resulting from or arising out of the acts or omissions of GoNetspeed or its agents in connection with the use and occupancy poles located within the public

right-of-way, except to the extent resulting from the acts or omissions of the Municipality.

- iii. GoNetspeed shall, at its own cost and expense, maintain commercial general liability insurance with limits not less than \$1,000,000.00 for injury to or death of one or more persons in any one occurrence and \$500,000.00 for damage or destruction to property in any one occurrence. GoNetspeed shall include the Municipality as an additional insured.
- iv. GoNetspeed shall be responsible for the repair of any damage to paving, existing utility lines, or any surface or subsurface installations, arising from its construction, installation or maintenance of its facilities.
- v. Notwithstanding any provision contained herein, neither the Municipality nor GoNetspeed shall be liable to the other for consequential, incidental, exemplary, or punitive damages on account of any activity pursuant to this instrument.

Section 2. Duration of Consent. The permission and authority hereby granted shall continue for the same period of time as the grant to parties whose poles GoNetspeed is using.

Section 3. Notices.

All notices or other correspondence required or permitted to be given in connection with this Agreement shall be in writing and delivered personally, by telecopy, by overnight carrier service or by registered or certified mail to the parties at the following addresses:
