RESOLUTION NO. 112-2012

TO HIRE A FULL TIME DEPUTY COURT ADMINISTRATOR FOR SHARED MUNICIPAL COURT

WHEREAS, the need exists to fill the position of full time Deputy Court Administrator for shared Municipal Court for the Cities of Northfield and Linwood; and

WHEREAS, having first been satisfied that the applicant has the necessary qualifications required for the position, Donna Clark, Municipal Court Administrator has recommended that Barbara Harrington be hired as full time Deputy Court Administrator for the shared Municipal Court for the Cities of Linwood and Northfield.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Governing Body of the City of Northfield that Barbara Harrington is authorized to be hired as full time Deputy Court Administrator, commencing July 25, 2012, subject to understanding and/or completion of the following:

- 1. Compliance with the Policies and Procedures of the City
- 2. Satisfactory results of Background Check
- 3. Satisfactory results of Physical Examination
- 4. Probationary period 90 days from date of hire
- 5. Longevity not included in negotiations since May 1996
- 6. Not Entitled to Chapter 88

IT IS FURTHER RESOLVED that compensation for Barbara Harrington shall be based on an annual salary of \$30,000.00. Said wage shall be separately set forth in the Municipal Salary Ordinance as required by NJSA 40A:9-140.10.

IT IS FURTHER RESOLVED that upon successful completion of the 90 day probationary period, that compensation for Barbara Harrington shall thereafter be based on an annual salary of \$32,000.00. Said wage shall be separately set forth in the Municipal Salary Ordinance as required by NJSA 40A:9-140.10.
