CITY OF NORTHFIELD, NJ RESOLUTION NO. 238-2025

WORK CHANGE ORDER NO. 1 FOR THE PROJECT KNOWN AS VARIOUS SANITARY SEWER MAIN AND MANHOLE REHABILITATIONS

WHEREAS, pursuant to Resolution of Council No. 120-2025, the City of Northfield did award a contract for the project known as "Various Sanitary Sewer Main and Manhole Rehabilitations" and did enter into a contract with Mobile Dredging & Video Pipe, Inc., in the amount of \$288,325.00; and

WHEREAS, the change order is in response to an emergent condition which occurred before certain work could be performed, involving the collapse of a portion of reinforced concrete pipe (RCP) in an area covered under the original scope of work; and

WHEREAS, subsequent to the resulting emergency repair that was performed on the collapsed RCP, DeBlasio and Associates consulted with Mobile Dredging & Video Pipe, and it was determined that there was a high likelihood of further collapse if slip line work, pursuant to the awarded contract, was attempted; and

WHEREAS, the contract is hereby amended to reflect the removal of the sanitary sewer main slip line work for all reinforced concrete pipe (RCP), the removal of all manhole and bench/invert rehabilitation work, and associated reduction in traffic control costs, with the adjusted quantities attached hereto as Exhibit A; and

WHEREAS, the net effect of these changes is a total decrease in the contract price of \$142,782.50 (-49.52%).

NOW, THEREFORE, BE IT RESOLVED that the Contract for "Various Sanitary Sewer Main and Manhole Rehabilitations" be and is hereby amended from \$288,325 to \$145,542.50.

Enclosed please find four (4) copies of CHANGE ORDER NO. 1 regarding the above referenced project for review and approval. Upon execution, please return three (3) copies to our office.

The change order is in response to the pre-installation video of the sanitary sewer mains conducted by Mobile Dredging & Video Pipe and the collapse of the reinforced concrete pipe (RCP) sanitary sewer main along Zion Road between Shore Road and Davis Avenue. The pre-installation video revealed poor conditions of all the RCP sanitary sewer pipe videoed within the project area, which prompted our office to investigate the feasibility of slip lining the RCP. During this time period, a portion of the RCP collapsed and required an emergency repair. With this in mind and having consulted with Mobile Dredging & Video Pipe, we determined that there was a high likelihood of further collapse if slip line work was attempted.

Given the similar condition of the collapsed RCP to the remaining RCP within the project area, we deemed the replacement of the RCP to be an emergency. As a result, we are reducing the scope of the project to exclude the slip lining of RCP sanitary sewer main. Furthermore, Mobile Dredging & Video Pipe provided concern with regards to the conditions of the manholes and the feasibility of performing the rehabilitation work. The City subsequently pursued a quote from Mathis Construction to replace the respective RCP and manholes on an emergency basis. Our office reviewed the quote provided and concurred that the pricing was reasonable and adequate for the work. During our review, the cost to replace the manholes was noted to be of similar cost provided by Mobile Dredging & Video Pipe for rehabilitation, at which point our office gave the recommendation to have the manholes replaced in their entirety.

Our office estimated a cost savings of \$134,304.00 for the reduction in work. The contractor and our office came to an agreement to reduce the scope of the work with a cost savings of \$142,782.50. Given that the contractor exceeded our estimate in savings, the scope of this change order was brought before Council and discussed during the October 21, 2025 Council Meeting and was met with no objections.

Please note that this change order reflects the following work requested by the City:

- 1. Removal of the sanitary sewer main slip line work for all reinforced concrete pipe (RCP).
- 2. Removal of all manhole and bench/invert rehabilitation work.
- 3. Reduction in traffic control costs.

Please note this change order will result in a decrease of \$142,782.50 to the original contract amount of \$288,325.00 for an amended contract amount of \$145,542.50.

WHEREAS, several members, including THE CITY OF NORTHFIELD, have placed a portion of their Surplus from amounts released in prior years, into the Aggregate Excess Loss Contingency Fund; and

WHEREAS, based upon the un-audited balance as of THE 2025 Financial Review, the CITY OF NORTHFIELD had an accumulated balance of approximately \$119,782.16 in the Aggregate Excess Loss Contingency Fund; and

WHEREAS, the Chief Financial Officer from the City of Northfield has sent a written request to the Fund Administrator's office asking that \$119,782.16 of their available balance be released from the Aggregate Excess Loss Contingency Fund.

Grant Applications

1. FY2024 NJDCA Local Recreation Improvement Grant (LRIG)

- The New Jersey Department of Community Affairs has announced that they are accepting LRIG applications and the submission deadline is February 27, 2024. The LRIG application was submitted on February 23, 2024.
- Grant awards were announced on May 31, 2024 and the City was awarded \$63,000.00.
- > The City requested that due to budget constraints, the project be revised to be closer in cost to the grant award. Our office contacted the NJDCA in February of 2025. The NJDCA will allow for a change in scope in the project and will allow engineering costs to be submitted with the construction estimate.
- > Our office submitted a revised proposal on March 12, 2025 based on this information.
- > The NDCA approved the revised scope of work of a stone parking lot and the inclusion of engineering design fees on March 21, 2025. A time extension request was not approved, and the project must be completed by April 2026.
- Project design is being finalized. NJDCA will allow for the City to receive proposals instead of bids based upon engineer's estimate.
- → Plans and Specifications submitted for City review on November 4, 2025.
- The project was advertised December 6, 2025 in the Press of Atlantic City. Proposals due December 30, 2025.

2. Atlantic County Improvement Authority Community Development Block Grant

- The City has selected the installation of ADA compliant bleachers at the five baseball fields at Birch Grove Park.
- Our proposal was submitted on April 28, 2025.
- The application was submitted on May 29, 2025.

3. New Jersey Department of Transportation State Aid Program

- Our proposal for this project was submitted on April 30, 2025.
- > The City will be holding a special meeting on June 16th to select a project.
- ➤ The application for the Resurfacing of Burton Avenue was submitted to the NJDOT System for Administering Grants Electronically (SAGE) on June 25, 2025.
- > The NJDOT issued notice of award on November 17, 2025 in the amount of \$254,125.00.
- Our office submitted a proposal on November 18, 2025.

4. New Jersey Department of Transportation Local Projects Fund (NJDOT LTPF)

- > The City has selected the reconstruction of Forrest Drive from Juniper Drive to Mill Road for FY2024 of the Local Transportation Project Fund.
- The application was submitted to the System for Administering Grants Electronically (SAGE) on June 26, 2024.
- This application was not awarded grant funding for the fiscal year 2024 under the Local Transportation Project Fund, as stated in a letter from the State dated May 13, 2025.
- > The City selected the Resurfacing of Cedar Bridge Avenue for the FY2025 of the Local Transportation Project Fund. The application was submitted to NJDOT System for Administering Grants Electronically (SAGE) on June 24, 2025.

5. New Jersey Department of Transportation Municipal Aid

- > The City has selected the reconstruction of Juniper Drive from Cedar Bridge Road to Mill Road as its project for FY2025 Municipal Aid.
- ➤ The City was awarded \$229,190.00 on November 13, 2024 for this project. The total project cost estimate is \$355,824.70.
- > Survey work has been completed and plans are being prepared.
- > The plans and specifications were approved by NJDOT, and the City was transmitted these documents on June 30, 2025 and notified that the project is ready for bid.
- Project bid date is August 5, 2025. Our office met with City officials on July 30, 2025 to coordinate project start date, resident letter and resident parking. Tentative project start dates is September 22, 2025 and the project duration is estimated to be 5 weeks.
- > The Preconstruction meeting was held September 16, 2025 at 10am.
- Project began on Thursday October 9, 2025.
- ➤ A change in scope for replacement of curb inlet piece and stormwater manhole casting and lid was approved. Milling of the street began on November 3, 2025, and paving was conducted the week of November 10, 2025. Striping will be conducted in the next week or two. Landscaping will be conducted in the Spring for better chance of root establishment.
- Traffic striping has been completed by the contractor.

Engineering

Slipline Repairs Zion and Mill Roads, Zion and Davis Roads

- The bid opening was held on April 10, 2025.
- > The City selected to award Bid Alternative #3, slipline repair and manhole rehabilitation at Zion and Mill and Zion and Shore Roads. A letter of recommendation was submitted to the City on April 23, 2025.
- ➤ Videoing of pipes at both locations began September 8, 2025 2025 and was completed September 9, 2025.
- ➤ A Pipe collapse occurred at Zion/Shore Road on Saturday October 4, 2025. Mathis Construction mobilized for emergency repairs. DBA is recommending full replacement in this location as well as sections of Zion and Mill Road due to similar pipe conditions.
- > The City has approved the replacement of piping at the Zion/Shore Road location and partial replacement at the Zion/Mill location.
- The County Engineer has approved that the Zion/Shore Road replacement work can be conducted during day hours. Mathis awaiting County permit approvals to begin work.
- Replacement work at Zion/Shore Road has been scheduled for Thursday November 20, 2025.
- The ACUA manhole in Shore Road is to be replaced by ACUA due to the condition of the manhole.

2. Habitat for Humanity Housing Project (Dolphin Avenue)

- Our office submitted a proposal for the Habitat for Humanity Project on Block 69 Lot 1.02 and Block 66 Lot 11 on August 5, 2024.
- ➤ The draft subdivision plans were transmitted to the City, Tiffanny Morrissey, and PHNX Development Partners on June 23, 2025. Our office is in the process of coordinating a meeting with the County Engineer, who received the plans on June 30, 2025.
- Our office met with City officials and Atlantic County on July 16, 2025 to discuss site plan requirements. A meeting is scheduled to be held with the City project team on August 7, 2025.
- Subdivision located on Harvey Drive to be modified to remove 4th unit due to conflict with intersection and setback requirements. PHNX proposed alternatives that are under consideration by the City and its representatives. Stormwater design has begun on the subdivision located on Dolphin Avenue.
- ➤ Draft plans were sent to Tiffany Morrissey on October 16, 2025 for the finalization of the Redevelopment Plan.
- The site has been partially cleared for soil samples and the samples were taken on November 17, 2025 for finalization of stormwater design.
