## CITY OF NORTHFIELD, NJ ORDINANCE 3-2017

## AN ORDINANCE AMENDING CHAPTER 111-35 OF THE CODE OF THE CITY OF NORTHFIELD TO REMOVE CERTAIN STREETS OR PARTS THEREOF FROM BEING DESIGNATED AS THROUGH STREETS AND AMENDING CHAPTER 111-36 TO ADD STOP INTERSECTIONS

**WHEREAS**, the City of Northfield has adopted Chapter 111-35 of the City Code, which designates certain streets or parts of streets as through streets;

**WHEREAS**, the City of Northfield has adopted Chapter 111-36 of the City Code, which designates certain intersections as stop intersections;

**WHEREAS**, the City of Northfield desires to improve public safety along Bay Drive; and

**WHEREAS**, the Municipal Engineer and the Northfield Police Department have recommended that the through street designation be removed from certain streets or parts thereof; and

**WHEREAS**, the Municipal Engineer and the Northfield Police Department have recommended that certain intersections be designated as stop intersections; and

**WHEREAS**, the City of Northfield desires to follow the recommendations of its professionals.

**NOW, THEREFORE, BE IT HEREBY ORDAINED AND ENACTED** by the Mayor and Council of the City of Northfield, County of Atlantic and State of New Jersey as follows:

**Section 1.** The following streets or parts of streets are removed from the current version of Chapter 111-35 Schedule VIII of the Code of the City of Northfield, and the following described streets or parts of streets are no longer designated as through streets:

Name of Street Limits

East Rosedale Avenue Between Shore Road and Bay Drive

**Section 2.** The current version of Chapter 111-36 Schedule IX of the Code of the City of Northfield is amended to include the following intersections as stop intersections:

Intersection Stop Sign On

East Rosedale Avenue at Bay Drive East Rosedale Avenue

**Section 3.** This Ordinance shall take effect upon final adoption, publication as prescribed by law and final passage and the completion of the installation of the required signs.
