

**CITY OF NORTHFIELD, NEW JERSEY
ORDINANCE NO. 9-2018**

**AN ORDINANCE AMENDING CHAPTERS 250 OF THE CODE OF THE
CITY OF NORTHFIELD, GOVERNING PARKS AND RECREATION
AREAS AND CHAPTER 111 OF THE CODE OF THE CITY OF
NORTHFIELD, GOVERNING VEHICLES AND TRAFFIC**

WHEREAS, City of Northfield Code Section 250 governs Parks and Recreation Areas in the City of Northfield; and

WHEREAS, City of Northfield Code Section 111 governs Vehicles and Traffic in the City of Northfield

WHEREAS, the Council for the City of Northfield desires to amend certain sections/sub-sections of Chapters 250 and 111; and

NOW THEREFORE BE IT RESOLVED by the Mayor and City Council of the City of Northfield, County of Atlantic, and State of New Jersey that Chapters 250 and 111 of the Code of the City of Northfield are hereby amended as follows (added text underlined; deleted text stricken):

CHAPTER 250

Article I

Issuance of Citations in Birch Grove Park

§ 250-1 Authority to issue.

A. The ~~Birch Grove Park Supervisor~~ Public Works Superintendent is hereby authorized to issue citations, file complaints and give notices for violations of any local municipal ordinance occurring on or within the premises of Birch Grove Park. The ~~Birch Grove Park Supervisor~~ Public Works Superintendent will not be empowered to arrest any person(s) on or within the premises of Birch Grove Park.

B. No change.

Article II

Birch Grove Park, Veteran's Park and First Street Playground Regulations

§ 250-2 Prohibited activities.

A. No alcoholic beverages shall be permitted within the confines of Birch Grove Park, Veteran's Park and the First Street Playground within the City of Northfield. This includes all structures and all lands within the metes and bounds

description of the parcels of property constituting Birch Grove Park, Veteran's Park and the First Street Playground.

B. No change.

C. No person(s) shall be permitted to deposit, leave or abandon any domesticated or nondomesticated animal or other living creature within the confines of Birch Grove Park, Veteran's Park and the First Street Playground in the City of Northfield. This restriction and prohibition is intended to be all inclusive.

D. No person shall park or stand a vehicle in or upon the Veteran's Park (as defined in Chapter 250-12 of the Code of the City of Northfield) or any of attendant and/or adjacent public parking areas between the hours of midnight and 6 AM.

A. Birch Grove Park shall be closed to all persons, with the exception of registered campers, between the hours of 8:00 p.m. and 9:00 a.m. or such other hours as may from time to time be posted at the entrance by the ~~Birch Grove Park Supervisor~~ Public Works Superintendent.

VETERAN'S PARK

The public area that includes but is not limited to all park/memorial areas located on Block 14, Lot 10.01 in the City of Northfield, commonly known as 1913 Oak Avenue in the City of Northfield.

Chapter 111.

Article XIII.E. ~~Birch Grove Park~~ Parks and Recreation Areas

§ 111-26.16. Parking prohibited; handicapped parking.

B. No person shall park or stand a vehicle upon the athletic field area or Veteran's Park (as defined in § 250-12 of the Code of the City of Northfield) or any of attendant and/or adjacent public parking areas between the hours of 12:00 midnight and 6:00 a.m.

REPEALER: All Ordinances or portions thereof which are inconsistent in whole or in part with the provisions contained herein are hereby repealed to the extent of any such inconsistency.

SEVERABILITY: If any portion of this ordinance shall be determined to be invalid, such determination shall not affect the validity of the remaining portions of said ordinance.

EFFECTIVE DATE: This ordinance shall take effect upon final passage and publication in accordance with law.
