

BE IT RESOLVED, by the Common Council of the City of Northfield, County of Atlantic, and State of New Jersey that Chapter 250, Article II, of the Code of the City of Northfield is hereby amended as follows (added text <u>underlined</u>; deleted text stricken):

Article II Birch Grove Park, Veterans Park, and First Street Playground, and Northfield Bike Path Regulations

§ 250-2 Prohibited activities.

- A. No alcoholic beverages shall be permitted within the confines of Birch Grove Park, Veterans Park, and the First Street Playground or the Northfield <u>Bike Path</u> within the City of Northfield. This includes all structures and all lands within the metes and bounds description of the parcels of property constituting Birch Grove Park, Veterans Park, and the First Street Playground and the Northfield Bike Path.
- B. NO CHANGE
- C. No person(s) shall be permitted to deposit, leave or abandon any domesticated or nondomesticated animal or other living creature within the confines of Birch Grove Park, Veterans Park, and the First Street Playground, or the Northfield Bike Path in the City of Northfield. This restriction and prohibition is intended to be all inclusive.

- E. NO CHANGE
- F. NO CHANGE

§ 250-3 Reserved use of athletic fields, or park facilities., <u>or the Northfield Bike</u> <u>Path or any portions thereof</u>

A. Definitions. <u>NO CHANGE.</u> As used in this article, the following terms shall have the meanings indicated:

ATHLETIC FIELD AREA NO CHANGE

BANDSTAND/GAZEBO NO CHANGE

NORTHFIELD BIKE PATH

<u>The municipal park pedestrian/bicycle recreation area also known as</u> <u>"Northfield Bike Path" located in the City of Northfield.</u>

RESERVED USE NO CHANGE

E.B. Application Required

- (1) Requests by outside organizations* for reserved use of any Northfield Municipal Facilities, or any use of athletic fields or the Northfield Bike Path must be coordinated through the City Clerk's Office, and must be submitted in writing, on the forms provided by the City of Northfield. It is a two-part process, consisting of a use of facilities application, and if approved, a use of facilities agreement. If use is approved, the requesting organization must abide by the insurance requirements as set forth in Section 250-3 C., below and in the use of facilities agreement.
- (2) <u>NO CHANGE. All requests for use of athletic fields or the Northfield</u> <u>Bike Path by outside organizations* require City Council approval and</u> will be considered by the City Council at a regularly scheduled meeting of the governing body. Meeting schedules can be found on the municipal website.
- (3) NO CHANGE.

*NOTE: Refers to groups other than the City of Northfield Cultural Committee.

C. Insurance Requirements

(1) All outside organization users approved for reserved use of the City's athletic fields or, the disc golf course in Birch Grove Park, or the Northfield Bike Path must abide by insurance requirements as set forth herein and in the use of facilities agreement.

(2) All outside organization users approved for reserved use of any other municipal facility(ies) consisting of 30 or more participants must abide by the insurance requirements as set forth herein and in the use of facilities agreement.

 \underline{C} . \underline{D} . Use of athletic field lights – No Change.

§ 250-4 Compliance with rules by groups seeking permits – No Change

§ 250-5 Permit required for groups in Birch Grove Park <u>NO CHANGE.-or-the</u> Northfield Bike Path

No group shall be permitted to utilize Birch Grove Park in the City of Northfield unless a permit shall have been obtained from the Clerk of the City of Northfield or the Clerk's designee. No permit shall be issued unless application is made not less than five business days prior to the contemplated use of the premises. If use is for any athletic field area, the Northfield Bike <u>Path</u>, or the Bandstand/Gazebo, said use is subject to the application procedures as defined in § 250-3.

B. As used in this article, the following terms shall have the meanings indicated:

GROUP or ORGANIZATION

A collective number of persons, being 10 or more in number, whether related or unrelated, and participating in an organized activity or outing involving the use of the subject premises or any portion thereof.

§ 250-8 Violations and penalties – No Change

BE IT FURTHER RESOLVED:

- 1) This ordinance shall take effect upon final passage and publication in the manner prescribed by law.
- 2) Repealer. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.
- 3) Severability. If any Section or part of this Ordinance is deemed to be invalid or illegal in any Court of competent jurisdiction then said part is severable from the Ordinance as a whole and the remaining sections or parts of this Ordinance shall remain in full force and effect.

Grant Applications

- 1. FY2024 NJDCA Local Recreation Improvement Grant (LRIG)
 - The New Jersey Department of Community Affairs has announced that they are accepting LRIG applications and the submission deadline is February 27, 2024. The LRIG application was submitted on February 23, 2024.
 - Grant awards were announced on May 31, 2024 and the City was awarded \$63,000.00.
- 2. USDA Water and Waste Disposal-Predevelopment Planning Grant (PPG)
 - On June 10, 2024 the USDA awarded the City \$17,000.00 for the PPG grant and the next step requires the City to file the full application.
- 3. <u>New Jersey Department of Transportation Local Projects Fund (NJDOT LTPF)</u>
 - The City has selected the reconstruction of Forrest Drive from Juniper Drive to Mill Road for FY2024 of the Local Transportation Project Fund.
 - The application was submitted to the System for Administering Grants Electronically (SAGE) on June 26, 2024.

- 4. New Jersey Department of Transportation Municipal Aid
 - The NJDOT has announced that the State is accepting grant applications for roadway, bikeway and pedestrian improvements.
 - The City has selected the reconstruction of Juniper Drive from Cedarbridge Road to Mill Road as its project for FY2025 Municipal Aid.
 - The application was submitted to the System for Administering Grants Electronically (SAGE) on June 25, 2024.

Engineering

- 1. Street Excavation and Sidewalk Ordinance
 - Our office was asked to review and revise the street excavation and sidewalk ordinance. We have been coordinating with the City to update this ordinance.
 - > Our office sent draft ordinance to the City on May 21, 2024.
 - > Our office met with the City on July 15, 2024 to review City revisions and comments.
- 2. Stormwater Management Plan
 - > The Stormwater Plan was submitted to the City on July 25th and project has been completed.
 - Upon the City's review of the Stormwater Plan, it was found the City's land ordinances have not been updated since 2007 regarding stormwater related matters. The City will conduct a comparison of land use ordinances against the stormwater ordinances adopted at the July 16, 2024 meeting and make revisions as needed.
- 3. Slipline Repairs Zion and Mill Roads, Zion and Davis Roads
 - The project was submitted to the Atlantic County Engineering department for review. The County is requiring the majority of the work to be conducted during the night.
 - Our office received input from the City's Public Works Department. We adjusted the bid documents accordingly and are waiting for City approval to set a bid schedule.
- 4. Emergency Stormwater Repair Cedar Bridge Road
 - Site inspection of the work was performed by the City. The work was completed on July 12, 2024. The City questioned during the July 16, 2024 meeting if the contractor had to restore and pave the road half-width per the street opening permit protocol. On July 22, 2024, DeBlasio issued an email to the City stating the emergency repair restoration does not fall under the terms of the street opening permit, but rather the contract between the City and Mathis. DeBlasio reviewed the contract, and there were no line items for paving restoration.
