# CITY OF NORTHFIELD COUNCIL MEETING MINUTES AUGUST 15, 2023

At 6:30pm this meeting was called to order by Municipal Clerk Mary Canesi, who welcomed the audience. This meeting was properly advertised in the Press of Atlantic City on January 7, 2023, and in accordance with Public Law 75, Chapter 231.

## **FLAG SALUTE**

The flag salute was led by Council President Pro Tempore Dewees, after which he asked all present to remain standing to take a moment to honor the memory of retired Deputy Chief Bob Leeds from the City of Northfield Volunteer Fire Company. Bob passed away on August 13<sup>th</sup>. He was a dedicated volunteer with deep ties to the community, and over 50 years of volunteer service.

Council Pro Tempore Dewees thanked everyone and announced that information regarding services for Bob had been shared by Chief Cummings and Clerk Canesi.

### **CITY ENGINEER'S REPORT**

Engineer Nassar reviewed the Engineers Report as previously distributed to Council. He reported that NJ American Water Company should be finished with connections this week, then we would need to wait 45 days for settlement before paving could occur. He was negotiating with them for payment in lieu of paving and would report further. There was a section of pipe on Oak Avenue that needed to be slip-lined, he would like to do this section instead of another section of town. He will prepare a change order for the next meeting. There would be no change in quantity, but the bid spec did have a map of streets that needed to be done.

## PUBLIC SESSION/FIVE MINUTES PER SPEAKER

Council President Polistina opened the public portion of the meeting for any person to comment on any subject, he asked that they state their name and address for the record and observe the five-minute limit per speaker.

Mayor Chau announced his presence via Zoom and shared a memory of working with Deputy Chief Leeds and offered condolences. He congratulated Mr. Hurley, winner of the recycling contest, adding that the toter would be delivered. For the past several years, Mayor Chau said he has worked with McDonald's on a program to reward children for bicycle safety in conjunction with the Northfield Police Department. By the end of this month, officers on patrol will have coupons to give to children who are bicycling safely.
