### **MAYOR'S REPORT**

Mayor Chau reported that at a recent Northfield Community School Board of Education Meeting, it was announced that Linda Albright, their School Business Administrator would be retiring. He congratulated her and wished her well. He urged Council to support the three resolutions to promote in the Police Department that were on the agenda this evening. He read the Chief's report for June.

Mayor Chau added that if there were any events that should be on the City calendar, please contact Deputy Clerk Campbell or Clerk Canesi to add them. Mayor Chau announced he was appointing Councilmen Polistina, Leeds and Dewees for the police negotiations committee, he had sent dates to our labor attorney and would advise of her availability.
