**Councilman Notaro** - Inspections, Housing/Zoning; Sewer Operations; Northfield Sports (FAN)

Councilman Notaro congratulated the Northfield Cardinals Varsity on their Cape Atlantic victory; Mainland Regional High School came up short but had great season as well. He, along with Councilman Polistina, attended the ACUA wastewater budget meeting. Councilman Notaro explained the proposed rate increase for 2025 and generally reviewed the overall increase over past 10 years, adding that they do a good job managing their budget. The slip lining project has had measurable impact on the efficiency of the system.
